1. What is a cookie?

A cookie is a small text file that is stored in your browser when you visit almost any web page. Its usefulness is that the web can remember your visit when you return to browse that page. Cookies usually store technical information, personal preferences, personalization of content, usage statistics, links to social networks, access to user accounts, etc. The purpose of the cookie is to adapt the content of the web to your profile and needs, without cookies the services offered by any page would be significantly diminished.

2. ¿What types of cookies are there?

Depending on their purpose, cookies can be:

- Technical/necessary cookies: help make a website usable by enabling basic functions such as page navigation and access to secure areas of the website. The website cannot function properly without these cookies.
- Personalization, functionality, or configuration cookies: Preference cookies allow the website to remember information that changes the way the site behaves or looks, such as your preferred language or the region you are in.
- Security cookies: prevent or hinder attacks against the website or its users.
- Analytics/Statistical Cookies: Statistical cookies help website owners understand how visitors interact with websites by gathering and providing information anonymously.
- Advertising cookies: manage the frequency and content of advertisements.
- Behavioral advertising cookies: store information about users to show them personalized advertising.
- Marketing cookies: Marketing cookies are used to track visitors to web pages. The intention is to show relevant and attractive ads to the individual user, and therefore more valuable to publishers and third-party advertisers.
